<u>Notice Concerning Introduction of Executive Officer System</u> <u>and Personnel Affairs of Officers</u>

CAREER DESIGN CENTER CO., LTD. (the "Company") announces that, at a meeting held on November 21, 2023, its Board of Directors resolved to introduce the executive officer system. Details are as follows. An official decision on this matter will be made at the 32nd annual meeting of shareholders scheduled for December 15, 2023 and the Board of Directors meeting held after the close of the shareholders' meeting.

1. Introduction of an executive officer system

(1) Purpose of the executive officer system

By clarifying management decision-making and the division of roles between supervisory functions and business execution functions, and by strengthening management and execution functions, the Company aims to build a structure that can respond more appropriately and quickly to changes in the Company's business environment.

(2) Overview of the executive office system

- (i) The appointment and dismissal of executive officers and the delegation of duties to be performed by them shall be based on a resolution of the Board of Directors.
- (ii) The term of office of executive officers shall be one (1) year and any executive officer may be reappointed.
- (iii) Directors may concurrently serve as executive officers.
